*SCHEDULE*

The decisions on minimum wages made by the Wages Board for Beedi Manufacturing and set out in the Schedule to the Notification Published in the *Gazette Extraordinary* No. 11208 of 29th November 1957 and varied from time to time were last published by the notification in the *Gazette Extraordinary* No. 1789/19 of 18th December, 2012. The decisions on minimum wages relevant to part II made by Commissioner of Labour after conferring on him the powers by the *Gazette* Notification No. 1916/13 of 27th May, 2015 to determine the minimum wages of this trade shall be notified as follows.

**Part II**

The minimum rates of wages for piece work

The minimum rates of the wages for piece work for Beedi Rolling (Inclusive of the preparation of wrappers for rolling, cutting, wrapping, leaves, filling wrappers with "Beedi Tobacco", Beedi Rolling and Tying rolled Beedies) shall be:

The minimum rates of wages for piece work for beedi Rolling (inclusive of filling wrappers with "Beedi Tobacco" Beedi Rolling and tying rolled Beedies but exclusive of the preparation of wrappers for rolling and cutting wrapping, leaves) shall be:

| (b) For 1,000 beedies not more than 2 inches long but less than 3 inches | Rs. 340.00 |

The minimum rates of wages for piece work for cutting, wrapping, leaves (inclusive of the preparation of wrappers for rolling) shall be:

| (b) For 1,000 beedies not more than 2 inches long but less than 3 inches | Rs. 220.00 |

The minimum rates of the wages for piece work for fixing ring labels round rolled Beedies shall be Rs. 50.00 per 1,000 Beedies.
