1. **The Chairman, Department Procurement Committee**, on behalf of the **Department of Labour** now invites sealed Bids for “**Interior Design for Department of Labour at “Mehewara Piyesa”, Colombo 05 (13th and 14th Floors (EPF) [Contract No: FG/TB/43/2025]**” as described below and estimated to cost **Rs. 10.5 million**.
The contract period is **91 Days**.

2. Bidding will be conducted through National Competitive Bidding Procedure (NCB).
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be registered in the field of **Building Construction** for Grade **C7 or above or Specialized Construction for Grade SP4 or above** with the Construction Industry Development Authority (CIDA). Valid until the date of closing of the bid. Further the registration should be valid at the date of award.

“The bidders shall also register themselves with Registrar of Public Contracts, Sri Lanka, in term of the Public Contracts Act No. 03 of 1987. The original certificate of registration (PCA 03) shall be submitted with the bid. The procurement shall not be awarded to any bidder unless such bidder had submitted the PCA 03 certificate”.

Sealed Bids shall be delivered or sent by registered post to the **Chairman, Department Procurement Committee (Minor), Finance Division, Department of Labour, 9th Floor, Mehewara Piyesa Building, Narahenpita, Colombo 05**, to reach **on or before 15:00 hrs on 27 May 2026**. Bids will be opened soon after closing at the same address in presence of the bidders’ representatives who choose to attend.
7. Bids shall be valid for a period of **77 Days** until **12 August 2026**.
8. All Bids shall be accompanied by a Bid Security, which shall be;

 - In favour of **Commissioner General of Labour**
 - For an amount **Rupees One Hundred Fifty-Five Thousand (Rs. 155,000)**
